



### **Application for Arts-Related Assistance**

Pawleys Island Festival of Music & Art (PIFMA) considers arts-related requests for funding. Those requesting assistance must meet the following criteria and complete the attached application.

- Requests from Georgetown County Public Schools to further the arts education of our children are given the highest priority.
- Other arts-related requests are considered on a case-by-case basis.

#### Funding criteria

1. Requests must be for no more than \$1,000.
2. Assistance must be used to support the arts, such as arts-related equipment, arts-related projects or special arts events.
3. A detailed report outlining the use of funding must be submitted within 30 days of the event/receipt of equipment/etc., including photos if possible and receipts of purchase for equipment.
4. Those receiving funding must be willing to be a part of PIFMA's marketing efforts.
5. Additional information may be requested by the PIFMA Board of Directors and must be received in a timely manner.
6. Applicants must be a church, school or designated as a 501 (c) (3) organization by the IRS and provide documentation.
